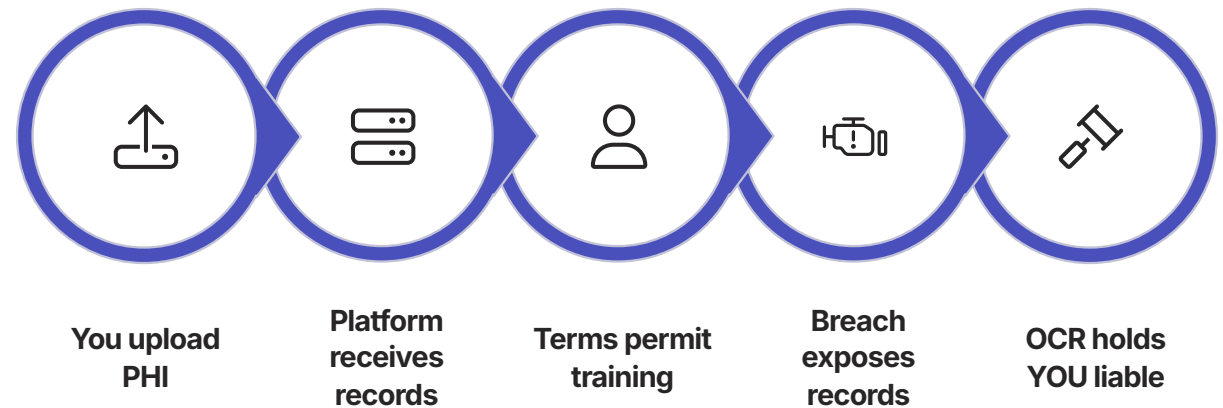
So you skip AI entirely. Your patients receive slower care. Your practice bleeds efficiency. And your competitors quietly pull ahead.

Why Cloud AI Violates HIPAA

When you upload a patient chart to ChatGPT or any cloud AI platform, you've already lost control — and HIPAA holds **you** responsible, not the vendor.



Even if no breach occurs, you're already violating the **Minimum Necessary Rule** — you don't need to send an entire chart to cloud AI when you could keep processing local. OCR's position is clear: promising to keep data safe is not a safeguard. Losing control of the data is the violation.

- ⊗ Your malpractice carrier: **"Cloud AI is explicitly excluded. You're not covered."** One breach can cost \$1M+ in fines, legal fees, and patient notifications.

How SAM Keeps Patient Data Secure

SAM is built specifically for healthcare compliance. Your patient records never leave your hardware — period. Here's how the architecture works in practice:



Local Storage

Charts and records live in secure OneDrive folders synced to a Mac mini in your office. SAM reads them locally — zero API calls to external servers. Zero patient data in the cloud.



Local AI Models

Routine clinical tasks — drug interaction checking, protocol verification, note summarization — run on local models (Gemma 2, Qwen, DeepSeek) entirely on your Mac mini. No cost per task. No cloud dependency.



Smart Extraction

For complex analysis, SAM extracts only the clinical question — never the raw patient record — before any cloud query. You maintain full control with a complete audit trail.

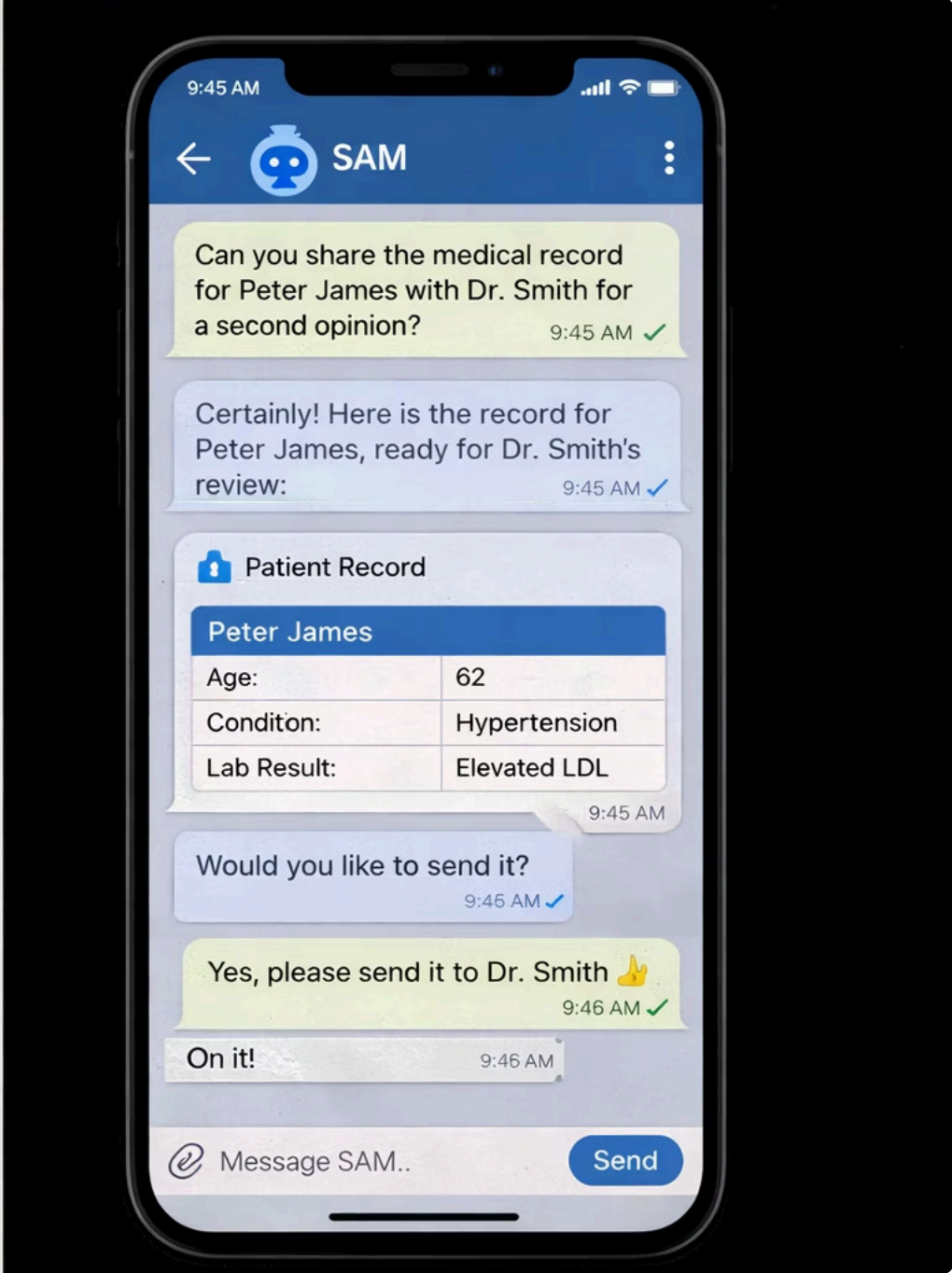
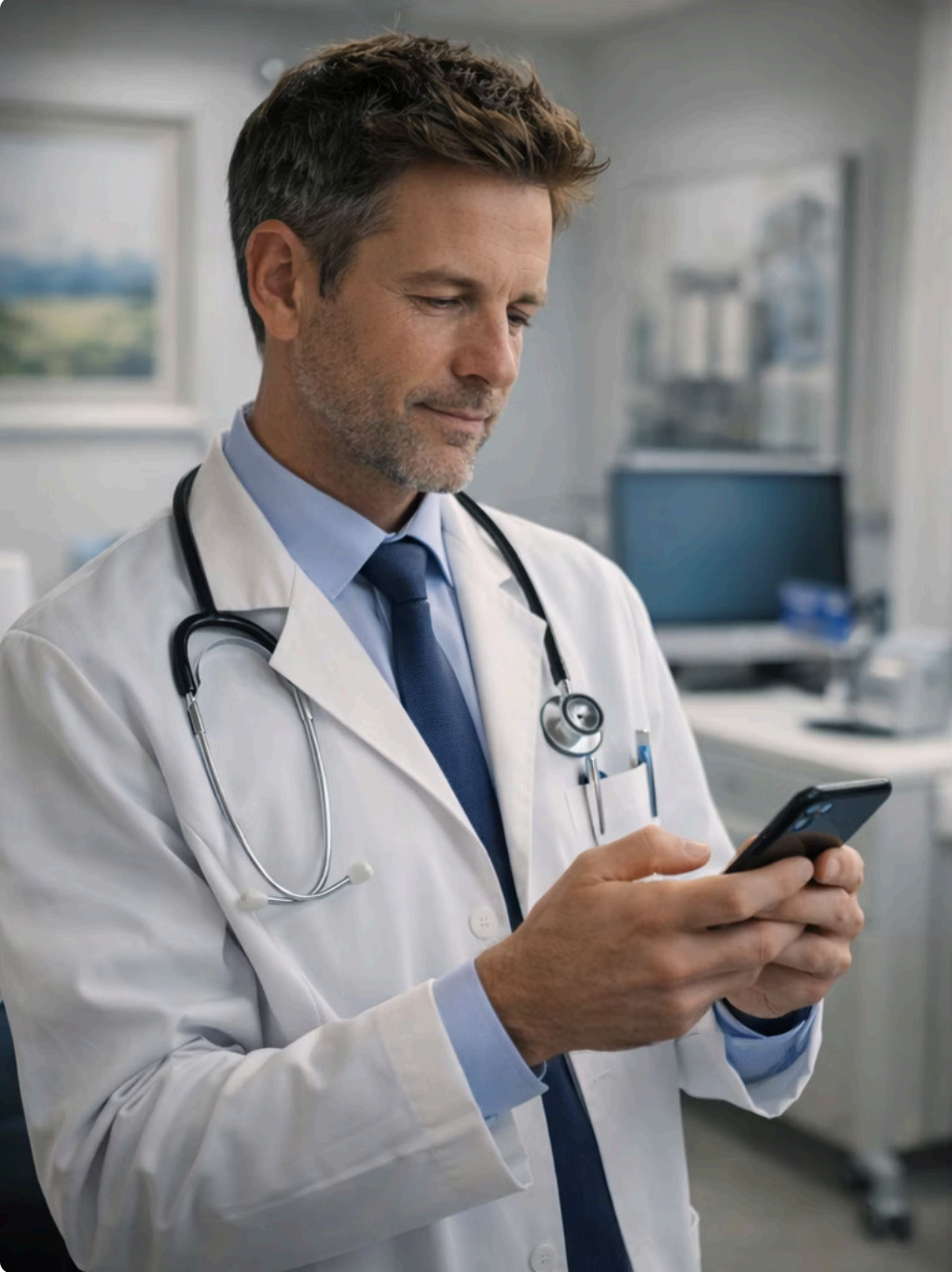


Compliance Stack
